FS 13/14-81 will be updated on the March 20 agenda and the Senate will be advised.

4. Enrollment Update College Year 2013-14: Ed Mills, AVP for Enrollment Management and Student Affairs, presented an update and will make a presentation to the Senate on March 20.
5. Timely Declaration of Major Policy: Exec discussed the item and determined that the APC policy amendments would not be reviewed until the President and the Provost have concluded their consultation on the matter and have responded back to the Executive Committee.
