1. Approval of the Agenda: Approved

3. From the Chair:

- November 19 Senate Meeting Debrief: The Executive Committee discussed the 11/19 meeting in particular the Senate actions on IPP. After extended discussion the committee determined that it would be best to have the Senate convene as a Committee of the Whole for discussion and clarification prior to voting on FS 13/14-42a/FL.

5. AITC Computer Lab Policy: Exec discussed the proposed policy presented by Coleman and Brady. The item will be placed on the January 30 agenda at First Reading.

Action language: The Faculty Senate recommends approval of impaction for the under graduate major in Biological Sciences, effective Fall 2015; contingent upon approval at all subsequent levels of review and the outcomes of the public meetings.
