Students in the Health Science major are pursuing a variety of careers in healthcare. As such, they need a strong foundation in the various dimensions of health (physiological, psychological, social, etc). The examination of socio-cultural aspects of health is one foundational area that is currently missing in the curriculum. When students enter the workforce, they must be equipped with the knowledge and resources to be able to serve a variety of populations and continue to promote diversity, equity, and inclusion in healthcare. This course will fill that gap in the curriculum.

HHS 140 examines the broad impact of health disparities in the United States on various populations including, People of Color, LGBTQ, Veterans, and People with Disabilities. Current events and case studies will assist students with exploring how to promote health equity through community-based models and programs.
