Briefly describe the program proposal (new or change) and provide a justification:

This program change proposal is a revision in our curriculum to address weaknesses in Program Learning Outcomes 1, 2, 3, 4, and 5.

An additional program learning outcome (PLO 7) is being proposed to introduce design research across the curriculum. The field of Design Studies is evolving and students are expected to master design research methods to achieve occupational success and to pursue graduate study.

- Changes to the Program Description and Learning Outcomes to clarify the goals and outcomes of the degree.
- Reduction in the number of required history courses
- Addition of an upper division course in Contemporary Topics in Design
- Addition of an upper division course in Design Research Methods
- Addition of an upper division Senior Seminar
- Addition of upper division pre-requisite for DSGN 101 to ensure students have the historical skills necessary to achieve success -Addition of one unit to the overall unit requirements
- -Addition of one lower and one upper division complementary studies elective to add interdisciplinarity and encourage declaration of a minor.

Additionally, the Department of Design is changing the common core of classes that all majors in the Department of Design must take. The objectives of these changes are to:

- Alleviate scheduling and facilities constraints that slow student progress to graduation
- Increase flexibility for students in scheduling their classes.
- Facilitate transfers
- Refine existing course needs to achieve program learning outcomes.

DSGN 4 will be required for the Interior Architecture B.F.A., Architecture B.F.A., Photography B.F.A and Graphic Design B.F.A., and Design Studies B.A.

DSGN 10 and DSGN 20 will be required for Photography B.F.A and Graphic Design B.F.A., and Design Studies B.A. and electives for the Interior Architecture B.F.A., Architecture B.F.A.,

Provide a fiscal analysis of the proposed changes:

The new smaller core should service the same number of students as the previous core while requiring fewer WTUs to implement with no additional facilities.

The WTU cost of the new courses will come from a reduction in sections as previously required courses become part of a pool of electives with fewer students taking each. No additional Tenure Track faculty will be needed for these changes to the degree assuming enrollment stays at current levels.

lan Harvey (iharvey) (Thu, 04 Apr 2024 18:31:08 GMT): Hi PJ. This is lan Harvey on behalf of the College Curriculum Committee. Your program proposal has been approved pending the following revisions. JUSTIFICATION Generally clear but it would be useful to specify which program learning outcomes are not being met and how the program changes address them. If there is a justification for the PLOs presented here due to NASAD requirements or others, then this should be addressed in the justification. Otherwise: PLOs (Remove the SLOs in any case.) PLO 2 "Employ" would be a stronger verb than "use" PLO 3 "recognize various levels" "Recognize" is a weak verb that could be replaced with "describe" or "articulate". Also, what kind of "levels" are we concerned with? Seems vague. Could one say: "Describe the various levels of communication"? Or "the various cultural levels"? There is a problematic repetition of the verb "recognize" PLO1, PLO3, PLO4. Maybe the PLO order should change to reflect progression of overall goals of the program: PLO 3 should be PLO5 as this knowledge follows on that of PLOs 4 and 5. In that case, PLO4 should be 3, and PLO5 should be 4, and PLO3 should be 5. PLO 7 'information gaps' seems vague. What kind of information gaps?
