Refocusing the course to include medical and psychosocial aspects of disability as one course rather than two. The content fits better together in one 3 unit course rather than split into two 3 unit courses, it is more fluid to teach the concepts together and we have one textbook to use for the content. It isn't heavy enough content for a years worth so it is better served for the rehabilitation students to take it as one course then add a different requirement that supports our BBS and CACREP requirements for Rehab.

This course focuses on intersection of medical and psychosocial aspects of disability including various congenital, hereditary, and trauma-induced disabilities along with psychosocial aspects such as the psychological genesis of and social implications affecting individuals with disabilities. The etiology, pathology, treatment, symptoms, prognosis, and limitations caused by various disabiling medical conditions and various psychological disabilities will be explored in concert with treatment considerations. The course will explore rehabilitation from a holistic standpoint to enhance coping and skill development.
