Justification for course proposal:

We propose a new upper-division course titled 'Social Entrepreneurship and Innovation.' Located in Sacramento, the capital city of California, Sacramento State College of Business is ideally located to offer such a course. The city's dynamic ecosystem of social ventures, coupled with easy access to government support, creates an ideal environment for aspiring social entrepreneurs and innovators. This proposed course aims to equip our students with the necessary skills and knowledge to launch and sustain social enterprises, thereby fulfilling the mission of the College of Business (COB) to 'develop engaged, responsible, and inclusive organizational members and leaders who enrich their communities.' Additionally, there is significant student interest in Social Entrepreneurship. A survey conducted in the Fall 2023 semester showed that 75% of the 73 students who took ENTR 187 and responded were interested in enrolling in a Social Entrepreneurship course, should it become available (detailed survey results are included in the attached file).

This course explores the concepts and practices of social entrepreneurship, which is the process of creating and scaling innovative solutions to social problems. The course will guide students through a systematic framework that covers all three phases of the start-up to scale-up process: pressure test, plan, launch and scale. The course will culminate in a final project presentation where students will showcase their social enterprise ideas or plans to the class.
