However, this section of the Catalog only states "Students may challenge courses by taking examinations developed at Sacramento State. Credit shall be awarded to those who pass them successfully." Recommend referring to the Credit for Prior Learning Policy instead. ♣ Page 10 state "Select one concentration from the following", but then there is a list of courses, with the concentrations lined out. I don't understand what these courses are. ♣ The courses listed under the heading "Concentration in Health Promotion (24 units)" (page 10) is not 24 units. It isn't clear how this section relates to the "Required Upper Division Courses" Section. ♣ Since PUBH 195 is 3-4 units, the section that it is listed under needs to have a range as well (e.g., the concentration can't list just 24 units).
