ABA Related University Committees:

Executive Safety Committee

Provide to President timely information, advice, and recommendations for action on significant campus Environment Health Safety, and Security (EHS). Committee participants in their role as representatives of all campus stakeholders receive input and communication from their campus stakeholders and present that input for the committee for consideration regarding hazards, risks, or concerns, as well as suggestions for improvement for significant campus EHS matters

Instructionally Related Activities (IRA) Committee

The IRA Advisory Committee acts as the advising body to the President for the Instructionally Related Activities student fee allocation. After a thorough review of applications, the IRA committee recommends to the President the suggested distribution of IRA funding to program applicants

Student Fee Advisory Committee

The Student Fee Advisory Committee (SFAC) is a shared governance advisory council to the President. SFAC helps balance the need to provide exceptional educational experiences to students with fair and appropriate fees to provide the materials and support for those experiences. In keeping with both Executive Order 1102 and Sacramento State policy and procedure, SFAC reviews fee action requests and ensures fees are fair and appropriate by submitting a selection of fees for audit each year. Committee recommendations on fee actions and audit reviews are submitted to the president for final review.

Transportation Advisory Committee*

The University Transportation Advisory Committee shall be the principal campus body responsible for recommending to the Vice President/CFO policy on all aspects of campus transportation. Committee members' responsibilities include reviewing and critiquing existing transportation programs; exploring and recommending new programs and modification or elimination of existing ones; recommending priorities for use of parking fines and forfeitures revenues; and aiding in the development of proposals, fee schedules and other matters related to the conduct of a comprehensive transportation management program.
