# **Program Description**

The concentration in History, Law, and Social Justice pairs courses in American legal and political history with a broad introduction to social issues and movements central to the development of American and global human rights regimes. The concentration is designed especially to prepare students for careers in law, but it also offers a well-rounded course of study for students interested in careers in politics, public policy, or social activism. Undergraduates in this concentration receive extensive training in critical thinking, evidence-based research, and analytical writing, preparing them to enter law school or other post-baccalaureate degree programs.
