Defining Framework

The discipline of history seeks to create an interpretive account of the human past from surviving evidence.

Historians:

- 1) value history as a means of understanding our contemporary world, while at the same time distinguishing the past from the present.
- 2) stress the importance of context, contingency, and complex causation for historical interpretation.
- 3) develop empathy toward people by recognizing how humans in the past and present shape their own unique historical moments and are shaped by those moments.
- 4) build interpretations using a wide array of evidence including written documents, physical artefacts, scientific data, and cultural expression.
- 5) create and disseminate public understanding of the diversity of human experience through engagement with big and enduring questions.
