Student Travel Instructions - Domestic Travel

This Student Travel Procedure applies to every University-related travel taken by any student.

The student traveler must complete the following steps below and submit all forms 30 Days Before the first day of Travel to the faculty supervisor:

- All students/volunteers must complete travel authorization forms every academic year. Most forms are submitted in Adobe Sign* for review and approval by the faculty supervisor and then by Risk Management 30 Days Before the first day of Travel.
 - 1. Open the Adobe Sign from the link received from the faculty supervisor.
 - 2. Read, sign, and submit the following forms:
 - o Release of Liability Waiver form.
 - o Emergency Contact Form.
 - o Photo Release form.
 - 3. Review the <u>Notice to Students: Release, Hold Harmless, and Informed Consent Provisions.</u>
 - 4. Driver Authorization:
 - o If a student is driving please use the Driver packet.

Failure to comply with these guidelines may result in unauthorized travel and the inability to reimburse students and faculty for their expenses.
