### FALL 2024 Submission & Review Deadlines



For the 2025-2026 catalog all course and program changes must be approved by all appropriate bodies (Curriculum Subcommittee, GE Course Review Subcommittee, Graduate Studies Policies Committee, Senate Executive, full Faculty Senate, and the President) no later than **February 7, 2025**. The publication date for the 2025-2026 catalog is April 9, 2025. Also noted are the deadlines by which experimental courses must be submitted by the college for approval prior to the registration period.

Double asterisk (\*\*) notes Academic Affairs deadline for inclusion for CMS Entry for Spring 2025 Schedule of Classes. However, College Committee will have to review these proposals during the October 4 meeting in order to meet the October 13 deadline.

Academic Affairs, in collaboration with the Faculty Senate, are working to ensure an efficient curriculum review process. *If courses are to be approved for CMS Entry for the Spring 2025 Schedule of Classes, the deadline is October 11, 2024. If courses are to be approved for CMS Entry for the Fall 2025 Schedule of Classes (excluding experimental courses), the deadline is February 7, 2025. We strongly encourage curriculum authors and review committees at the various levels to utilize the curriculum review checklists to ensure the proposals meet the requirements and guidelines for approval.*
