For Fall 2024 registration instructions, follow the information below. See specific registration requirements under your appropriate program listed.


Important Details:

Check your Student Center on MySacState to confirm your enrollment appointment date. New Admits will receive their registration appointment once admitted by the Office of Graduate Studies (OGS). Please be sure that you have “**Accepted**” your admissions from OGS through your [MySacState](#) Student Center.

- Registration information:
 - for [Continuing Students](#) registration is currently open.
 - for [New Admits](#) registration will begin soon.
 - **NOTE: fees due within 14 days of registering**
- Post-Bachelors (graduate-level) credential students will be allowed to enroll in a maximum of 28 units. If you receive an “enrollment cap” error, please do not panic, just let us know and we will reach out to the Registrar’s Office.
- If you experience registration errors and are unable to enroll in a course(s) please contact the Teaching Credential staff (contact info listed below). *It is important that all HOLDS are cleared so that staff can add you without delays.*
- Remember to check your emails daily over the break for important announcements from the Teaching Credentials department AND to visit the [Current Student](#) on the Teaching Credentials website for the most up-to-date information.
- The schedules below are ONLY for the Fall 2024 semester, I will send a separate schedule in late November, 2024 for your Spring 2025 courses.
- For Multiple and Single Subject candidates, please register for your indicated courses and in early August, you may be moved to another section once the cohorts have been established.
- If you are enrolling in a field placement course in the Fall, you MUST set up and monitor your CSUS email address ASAP to receive your placement assignment. We will ONLY use your CSUS email!
