### Catalogue Course Description:

CSAD 620 Clinical Methods: Communicating with Patients.

1 Unit

Prerequisite(s): Admission to doctorate program in audiology; <u>CSAD 610</u>.

Corequisite(s): <u>CSAD 620C</u>.

Communicating with patients. The nature of health communication among providers, patients, families, and caregivers. Topics related to multicultural issues will also be presented.

#### Place of Course in Program

This methods course focuses on communicating with patients and families. Students will learn about styles of communication, strategies for resolution and decision-making, the audiologist-patient relationship, and patient advocacy. Multicultural aspects of communication will also be discussed.

#### **Class Assignments:**

Rubrics for all assignments will be available on Canvas. Turnitin.com will be used for written assignments submitted online.

**G&G** assignments: There will be 13 weekly "G&G" assignments and one final G&G assignment in this course. Information about these weekly assignments can be found on Canvas. Missing or incomplete G&Gs will receive a 0.

<u>Discussion board posts</u>: There are 11 discussion board posts in this course. Each question relates to the content covered in the course and their clinical course, CSAD 620C. See Canvas for assignment details, requirements for responses, and the rubric.

**Reflection-on-action forms**: Students will submit a midterm and final week evaluation of their performance in clinic through CALIPSO. This form can be found on Canvas. It must be submitted to Canvas and CALIPSO for full credit per the rubric found on Canvas.

<u>Grand rounds presentation</u>: Students will present a case from clinic using the grand rounds format and an evidence-based approach around any of the topics discussed in the course. Requirements for the presentation can be found on Canvas.

### Diagnosis and Management

2. Apply audiologic diagnosis, treatment and management principles in diverse settings including, for example, private

practice-based, educational and occupational/industrial environments.

- 3. Apply critical thinking skills to assess the patient's auditory and vestibular status.

- 8. Discuss the findings, diagnosis and treatment options with the patient, parent or guardian, family, other health care or service providers, as well as any modifications or consequences that may occur over the course of treatment.

#### Communication

- 1. Communicate effectively, both orally and in written form, with patients, families, caregivers, and other healthcare and service providers.
- 3. Demonstrate empathy and active listening behaviors for patients and families.
- 4. Demonstrate understanding and respect for all individuals encountered in audiologic practice, regardless of disability, income, gender, sexual orientation, race, religion, culture or national origin.
- 7. Advocate for patient-centered care and shared decision-making by teaching self-advocacy skills to patients and family members.
- 8. Model and apply the skills needed to provide effective patient/family-centered counseling and shared decision-making when providing information, resources and evidence-based options for diagnosis and treatment.

- 1. Adhere to professional ethics as they relate to the practice of audiology.
- 2. Demonstrate sensitivity to the psychosocial dynamics of the doctor/ patient relationship.
- 3. Describe social, cultural, psychological, and economic forces affecting diverse patient populations.
- 4. List professional, legal, public health, and public policy issues as they pertain to the various practice settings and community needs
