Sports Economics Economics 186 Perez – Spring 2013 Sacramento State

Description:

Sports Economics introduces essential core economic concepts and then develops them with examples and applications from the sports industry. The sections are devoted to illustrating prominent areas of economics: industrial organization, public finance, labor economics, and econometrics. This course assumes only a basic, one-semester understanding in microeconomics.

Course Objectives:

- Industrial Organization in Sports: Students will develop and apply basic market structure models to the sports industry.
- Labor Markets in Sports: Students will develop and apply basic labor market models to the sports industry.
- Public Policy in Sports: Students will develop and apply public policy models to the sports industry.
- Econometrics: Students will learn how to run and interpret basic regression analysis.

Reading:

The required textbook for this course is Sports Economics by Rodney Fort

You will be required to read several articles that are available electronically from any Sacramento State computer. The readings are available in SacCt within the "Course Outline" link. You are expected to read all of these articles and be prepared to discuss them in class, refer to them in homework, and be prepared to answer questions about them on exams.
