What Is Happening In The PERS Lawsuit (in brief)

A coalition of public employee and retiree organizations filed suit on August I in the 3rd District Court of Appeal. The statewide Emeritus association (CSU-ERFA), with which we are affiliated, is one of the petitioners. One of the major arguments is that the expropriation of \$1.6 billion of PERS money was in violation of the State Constitution, which requires that PERS assets which are trust funds must be used 'tfor the exclusive purposes of providing benefits to participants in the pension and retirement system and their beneficiaries and defraying reasonable expenses of administering the system." Art. XVI, Sec. 17. This money was used to reduce

employer contributions to PERS.

AS 702 also took key powers away from the elected PERS Board and turns them over to an actuary appointed by the Governor, who can be fired without cause on 30 days notice. It also requires new state employees to go into a Tier 2 retirement system, which is non-contributory, but which has about half the benefits of Tier 1. Over time, the employee contribution fund, the earnings of which are to finance the major part of the program to replace the repealed IDDA/EPDA, will thereby be depleted.

The Governor's response argues that the AB 702 scheme is superior to IDDA/EPDA because it is a permanently funded program with a similar goal of restoring pensions up to 75% of their initial purchasing power, funding this with 1.1% of the

net earnings on employee contributions, plus a lower interest rate on contributions of those who leave before retirement.

Plaintiffs counter this by pointing to the tact that the program will fall far short of 75% if inflation exceeds 5%, and that the funds will be greatly depleted by the impact of Tier 2. Also, if the court rules the expropriation of funds to be unconstitutional, AS 702 repeals the inflation compensation program. A further concern is the possible loss of tax-exempt status for the employer contributions, which would then have to be included in the gross income of the employee for federal tax purposes.

Oral arguments are expected in January, with a decision in late spring.
