AFFILIATION WITH THE STATEWIDE EMERITUS AND RETIRED FACULTY ASSOCIATION?

has come up. Wilma Krebs, the CStJS representative to their State Council, has some thoughts on the matter:

Many of us are members of both our campus Emeritus Association and the Statewide CSUERFA, but our local organization has not

On a number of occasions, affiliation with the CSTJ Statewide ERFA

voted to affiliate with the latter. One of the main arguments in favor of affiliation is to strengthen the CSUERFA in dealing with the Legislature, PERS, CFA, and the CSU administration. Last year, CSUERFA provided seed money and leadership in working for repeal of the Medicare Catastrophic surtax, saving retired faculty close to \$1,000 a year (double for a couple). In the future, we can anticipate threats to state-financed health benefits. We also need to work for decent cost-of-living

adjustments.

Coalition. It has liaison representation in the CSU State Academic Senate and CFA State Assembly. It has developed a computerized database of all retired faculty.

What will affiliation cost? It does not require that all members of the local organization be members of CSUERFA, only that

CSUERFA has over 1,200 statewide members, having representatives

on the PERS Betterment Committee and the California Senior

What will affiliation cost? It does not require that all members of the local organization be members of CSUERFA, only that representatives to the State Council be members (one representative for each 75 members). Travel to the State Council meetings is largely subsidized by the state organization. Campus affiliates will receive an offsetting rebate of 15% of the amount of CSUEREFA dues from that campus.

I believe that the benefits far exceed the costs and recommend that we vote to affiliate with CSUERFA.
