Apply for Financial Aid

The **2025-26 Financial Aid Applications open on December 1**. To qualify for maximum aid, students should apply by the priority deadline of March 3. This application will cover the upcoming fall, spring, and summer semesters. Even if you only plan to attend for one semester, it's still a good idea to apply by the priority deadline to be considered for state funds.

Type of Financial Aid Applications

Review the criteria below and apply for **ONE** financial aid application that applies to you; *do not apply for both*. Both applications will require **Sac State's federal school code 001150**.

 - Be a U.S. Citizen or Permanent Resident
 - Have a valid Social Security Number (SSN)

 - Not a U.S. Citizen or Permanent Resident
 - Be an AB540/ Deferred Action for Childhood Arrivals (DACA) status

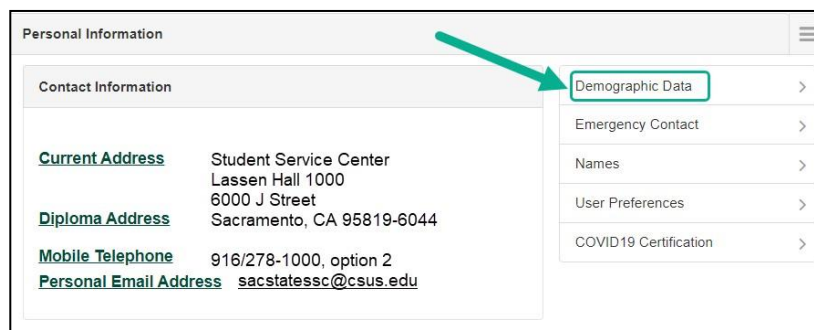
Financial Aid Application Submission

Once you've applied for financial aid, Sac State will reach out to you by email with your next steps. If you're starting in the fall, you can expect to hear from us starting in the winter, the year before you start school. For spring admits, notifications will be sent out in late November of the academic year you plan to transfer. For example, if you're transferring in Spring 2025, you'll get your status update in November 2024. Make sure to check your CSUS Outlook email for notifications, and you can also see any updates on your My Sac State account.

FAFSA Applicants Only: Verify Social Security Number (SSN)

Students with a Social Security Number (SSN) must report their number on their My Sac State account. This allows Sac State to retrieve your FAFSA from Student Aid to your student account. Follow the steps below to confirm or add your SSN.

From the Student Center page, locate *Personal Information* and select *Demographic Data* (see image below). Then, select 'Menu' on the top left of the page to show the "Add SSN" option.

Financial Aid Fee Deferment

A financial aid fee deferment is a **positive hold** that overrides your registration fee due date and prevents late fees from incurring up till the second week of the semester. *Financial aid students will be granted a fee deferment if certain conditions are met.* It will automatically be assigned to their student account on the *Student Center > Holds* section for the fall/spring semesters. By having this deferment, no immediate payment of tuition fees is required up till the second week of the semester. Check your *Student Center > Holds* for to determine if you are eligible.

Note: The fee deferment is an informational hold and won't stop you from registering or receiving your aid. It's your responsibility to submit all required financial aid documents and clear any holds before the semester starts to ensure your aid is disbursed on time.

Spring Transfers: Additional Steps Required

Consider the following, if applicable:

1. **If you attended another school in the fall and received aid prior to transferring**, you **must** close out your financial aid file at your previous institution after accepting your admission to Sac State. Students are not permitted to have two active financial aid applications within the same semester. Students may need to contact their previous school for closing instructions or to confirm file closure. **It may delay financial aid disbursements at Sac State if not completed.**
2. **It is the student's responsibility to add Sac State's school code 001150 to their financial aid application** to ensure that the university receives their financial aid application. **Your financial aid application does not automatically transfer to Sac State.**
3. **If you are a Cal Grant recipient**, it is the student's responsibility to update Sac State as the primary school on your [WebGrants 4 Students \(https://mygrantinfo.csac.ca.gov/\)](https://mygrantinfo.csac.ca.gov/) account so Sac State can receive your award information. Without this update, we will not be able to determine the student's Cal Grant and/Middle Class Scholarship eligibility. *If you have questions about your WebGrants account, please contact the California Student Aid Commission (CSAC) at 888-224-7268 (toll free).*

Processing & Awarding

The student will receive an award notification email when awards are posted to their account.

- **Newly admitted fall undergraduate students** will receive a “provisional award offer,” which is an estimate of their potential financial aid award. *These awards cannot be accepted, view-access only.*
- **Continuing students:** are typically awarded in the summer, after spring grades are posted.

Students will be notified when award offers will be posted to your *Student Center > Accept/Decline Award Link*.

- Grants/Scholarships will be **automatically** accepted on the account.
- Student loans will appear in “offer” status and a student may choose to accept/decline the offers. **Students are not required to take out loans to attend Sac State but is a resource if needed.**

How does financial aid pay my charges?

- (FAFSA Applicants only) I have a SSN and confirmed/updated to My Sac State account.**
